IMPACT: THE PROGRAM PLACED 32 GRADUATES INTO INITIAL EMPLOYMENT, EARNING AN AVERAGE OF \$19.06/HOUR. IN ADDITION, 17 ALUMNI WERE PLACED INTO NEW POSITIONS OR ADVANCED TO AN AVERAGE OF \$23.03/HOUR. 67% OF
